Sub: Staff welfare – Scholarship to the children/spouse of company employees for higher education above secondary level for the year 2023-24 – applications called for:

It has been decided to give Scholarship to the children/spouse of company employees for higher education above secondary level, for the year 2023-2024, as was done in the previous years. Children/spouse of company employees studying in an Aided/Govt./Govt. recognized institution for a course above secondary level, who have passed the basic qualifying examination with marks 60% /B Grade and above are eligible for the scholarship.

Employees, whose children/spouse are/is eligible for scholarship may submit applications in the prescribed form (specimen enclosed), along with the following documents:

- 1) Photocopy of mark list of the basic qualifying examination (Attested by employee)
- 2) Course certificate from the institution where they are studying, specifying the name of course and the semester/year.

In the case of those who have been granted scholarship in last year and continuing the same course in this year, the course certificate and mark list need not be enclosed with the application. In such cases, the declaration by the employee, which is included in the application form, will suffice.

The application in the prescribed form along with the required documents should reach the Head Office **on or before 15.01.2024**. Applications received thereafter will not be considered on any account.

The Unit Heads are directed to ensure that the contents of this circular are brought to the notice of all the staff in their unit. They are also directed to collect and forward the application with required documents, so as to reach the same **in H.O. before 15.01.2024**.
